I agree to abide by the following rules & regulations:

- WORK IS ONLY PERMITTED MONDAY – FRIDAY, 8AM-8PM AND WEEKENDS AND HOLIDAYS, 9:30AM-1:30PM.
- LEAVES MAY NOT BE BLOWN INTO THE STREET. LANDSCAPER IS RESPONSIBLE FOR DISPOSING OF ALL YARD WASTE - NO DUMPING ANYWHERE IN THE VILLAGE.
- ALL MACHINERY AND CONTAINERS MUST SIT ON DROP CLOTHS. OIL AND GAS MUST BE POURED FROM ONE CONTAINER TO ANOTHER OVER A DROP CLOTH.
- IT IS PROHIBITED TO SPILL ANY OIL, GAS, FERTILIZERS OR PESTICIDES ON THE STREET OR GROUND.
- NO TREES MAY BE CUT DOWN (DEAD OR ALIVE) WITHOUT A VILLAGE PERMIT. PERMIT FEE FOR REMOVAL: \$125.00 PER APPLICATION.
- EVERY LANDSCAPER'S VEHICLE, INCLUDING TRAILERS, MUST HAVE A VILLAGE OF ROSLYN ESTATES REGISTRATION STICKER ON THE LEFT REAR BUMPER.
- SNOW MAY NOT BE SHOVELED OR PLOWED INTO ANY VILLAGE ROADWAY, VILLAGE RIGHT OF WAY OR VILLAGE RESIDENTS' PRIVATE PROPERTY.
- **Pursuant to Village of Roslyn Estates Code; Section 106-8 (A):** "The operation within the Village of (i) any lawnmower, leaf blower, power washer or other internal combustion engine-powered, or solar-powered, battery-powered, electric-powered or other similar power-operated gardening or home maintenance equipment shall be prohibited at all times except between 8:00 a.m. and 8:00 p.m. on weekdays, excluding holidays, and except between 9:30 a.m. and 1:30 p.m. on Saturdays, Sundays, and holidays, or (ii) **any internal combustion engine-powered leaf blower shall be prohibited at all times on Saturdays, Sundays, and holidays during the period from June 1 through September 15.**"

VIOLATION OF ANY OF THE RULES AND REGULATIONS MAY RESULT IN SUSPENSION OR REVOCATION OF LICENSE AS WELL AS PROSECUTION.
